**9:30 am USP <800> Compliance in Community Practice– Hazardous Drug
Handling Practical Compliance Strategies for Independent Medical
Practices**

Although the potential therapeutic benefits of compounded sterile hazardous drug preparations generally outweigh the risks of their adverse effects in ill patients. The risks to healthcare workers providing these essential therapies risk similar adverse effects with no therapeutic benefit.

Hazardous drugs as compounded sterile preparations (CSPs) must be handled and prepared only under conditions that protect healthcare workers. This session will attempt to describe practical strategies to reach compliance with USP General Chapters <797>, and <800>, as well as relevant OSHA, and NIOSH regulations that impact the handling of hazardous drugs by healthcare personnel.
